

2023 Ziegler Luke Bryan Concert Sweepstakes Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. THIS SWEEPSTAKES IS VOID WHERE PROHIBITED BY LAW.

Eligibility: Sweepstakes participants must be a United States resident and at least 18 years of age at the time the sweepstakes begins. The Ziegler Luke Bryan Sweepstakes is void outside of the United States, or where prohibited or restricted by law.
