

# **Official Rules of the 2025 Ziegler “Tow and Go” Sweepstakes (the “Sweepstakes”)**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING. CHANCES OF WINNING ARE DEPENDENT UPON THE NUMBER OF ENTRIES RECEIVED.

This Sweepstakes is governed by the laws of Minnesota. You are not authorized to participate in the Sweepstakes if you are not a legal resident of Minnesota or Iowa. These Official Rules may not be published or distributed without the Sponsor’s written consent.

## **1. SPONSOR**

This Sweepstakes is sponsored by Ziegler Inc. located at 901 West 94<sup>th</sup> St. Bloomington, MN 55420.

## **2. ELIGIBILITY**

The Sweepstakes is open only to legal residents of Minnesota and Iowa (collectively, the “States”), who are twenty-one (21) years of age or older at the time of entry. Entries are void outside the Ziegler Inc. territory (see map) and where prohibited, taxed or restricted by law. Prize award is contingent upon meeting Sponsor’s qualification criteria, including but not limited to passing a credit check and providing a valid Tax ID. Officers, directors, managers, and employees of Ziegler Inc.(the “Sponsor”), and each of its respective parents, subsidiaries, affiliates and related companies and their respective advertising and promotion agencies, consultants and agents, as well as immediate family members and/or those living in the same household of each such person, and any others engaged in the development, production, execution or distribution of this Sweepstakes, are not eligible to participate. “Immediate family member” shall be deemed to mean spouse, children, parents, siblings and siblings-in-law. Sweepstakes may only be entered in or from the States and entries originating from any other jurisdiction are not eligible for entry. All federal, state and local laws and regulations apply.

## **3. DATES OF SWEEPSTAKES**

The Sweepstakes begins at 12:00:01am Central Time (“CT”) on May 1, 2025 and ends at 11:59:59 pm CT on July 11, 2025 (the “Sweepstakes Period”). Entries submitted before or after the Sweepstakes period will not be eligible.

## **4. HOW TO ENTER**

- Online Entry: Visit [info.zieglercat.com/tow-and-go](http://info.zieglercat.com/tow-and-go) and follow the instructions to enter the Sweepstakes.

The form must be completed in its entirety by submitting all answers to the form questions. After completing the form, click the “Submit” button. Upon clicking the “Submit” button, Entrant may be prompted to complete the entry form in its entirety to include first name, last name, street address, city, state, zip, phone number and email address (if available)

and click “Continue”. If prompted, entry form must be completed in order to be eligible to win. Then, complete the check boxes and click “Submit” to receive one (1) entry into the Sweepstakes. The form must be completed within the valid Sweepstakes date and by 11:59:59pm CT on July 11, 2025.

OR

- Store Visit: Visit a Ziegler store location in Minnesota, Iowa, and have a consultation with a sales representative.

Limit one entry per person, per household, regardless of the method of entry. Any attempt by an Entrant to obtain more than the stated number of entries by using multiple/different identities, and/or any other methods will void that Entrant’s entry and that Entrant may be disqualified from the Sweepstakes. Entries submitted by anyone other than the Entrant are void. In case of dispute as to the identity of any Entrant, entry will be declared made by the registered name and address on such entry. Any potential prize winner may be requested to provide Sponsor with proof that such person is the prize winner.

Sponsor is not responsible for any entry that is lost, late, illegible, stolen, mutilated, incomplete, invalid, unintelligible, whether due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, human error, entries not received resulting from any hardware or software failures of any kind, lost or unavailable network connections, failed, incomplete or garbled computer or telephone transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise. Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsor or Sweepstakes Entity.

## **5. DRAWING ODDS/WINNER SELECTION**

On or about July 15, 2025, potential prize winners will be selected in a random drawing from all eligible entries received during the Sweepstakes Period. By entering the Sweepstakes, Entrants fully and unconditionally agree to be bound by these Official Rules and the decisions of the Sponsor and Sweepstakes Entities, which will be final and binding in all matters relating to the Sweepstakes. The odds of winning depend on the number of eligible entries received.

To be eligible to receive a prize, all Entrants must complete the required [rental](#) agreement, which includes a credit check, and the provision of a valid Tax ID. Failure to meet these requirements will result in disqualification as outlined in Section 11. An alternate winner will be selected in a random drawing from the remaining eligible entries. ## **NOTIFICATION OF WINNER**

The winner will be notified by phone or email on or about July 15, 2025. If the winner does not respond within five (5) days of notification, the prize will be forfeited and an alternate winner will be selected.

## **6. PRIZE**

One (1) prize will be awarded, consisting of:

- A Towmaster T-12D trailer 18' (Total approximate retail value \$9,000)
- A free rental of a Cat 250 Skid Steer Loader for twelve (12) months, from August 1, 2025, to August 1, 2026, or until 500 operating hours have been reached, whichever comes first. The total ARV of the rental is \$37,200.

The total ARV of the prize package is \$46,200. The prize is non-transferable, and no substitutions will be made, except at the Sponsor's discretion.

In the event that the advertised model (e.g., the Towmaster T-12D trailer or the Cat 250 Skid Steer Loader) is unavailable at the time of the drawing, a model of equal value will be provided, subject to availability and at the sole discretion of the Sponsor.

## **7. CONDITIONS**

Winner must accept the prize as described or forfeit it. Prize is non-transferable and cannot be exchanged for cash. By participating, entrants agree to be bound by these official rules and the decisions of the Sponsor, which are final and binding in all matters relating to the Sweepstakes.

Neither Sponsor nor anyone acting on its behalf will enter into any communications with any Entrant regarding this Sweepstakes, except as expressly set forth in these Official Rules. Sponsor may prohibit an Entrant from participating in the Sweepstakes or winning a prize if, in its sole discretion, it determines that said Entrant is attempting to undermine the legitimate operation of the Sweepstakes by cheating, deception, or other unfair playing practices (including the use of automated quick entry programs) or intending to annoy, abuse, threaten or harass any other Entrants, Sponsor, or Sweepstakes Entities. If for any reason this Sweepstakes is not able to be conducted as planned, including, but not limited to, by reason of infection by computer virus, bugs, tampering, unauthorized intervention, fraud or any other causes beyond the reasonable control of Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes, then Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Sweepstakes and randomly draw from those entries received up to the cancellation/suspension date to award prizes. SPONSOR'S FAILURE TO ENFORCE ANY TERM OF THESE OFFICIAL RULES SHALL NOT CONSTITUTE A WAIVER OF THESE PROVISIONS.

## **8. PUBLICITY**

By accepting the prize, the winner agrees to allow Ziegler Inc. to use their names, addresses (city and state), voices and/or likenesses for purposes of advertising, promotion and publicity, for this Sweepstakes only, without further compensation, unless prohibited by law.

## **9. RELEASE**

By participating, Entrants and prize winners agree to release, discharge, indemnify and hold harmless the Sponsor, and each of Sponsor's respective officers, directors, employees, representatives and agents (collectively, the "Released Parties") from and against any claims made by any Entrant, prize winner, or any other third parties, related in any way to the operation of this Sweepstakes as well as any other claims, damages or liability due to any injuries, damages or losses to any person (including death) or property of any kind resulting in whole or in part, directly or indirectly, from receipt, acceptance, possession, misuse or use of a prize or participation in any promotion related activity or participation in this Sweepstakes.

By participating in the Sweepstakes, Entrants hereby agree to Sponsor's collection and use of their personal information and acknowledge that they have read and accepted Sponsor's Privacy Notice.

## **11. DISQUALIFICATION**

Any attempt to enter the Sweepstakes through fraudulent means or any violation of the Sweepstakes rules may result in disqualification at the sole discretion of the Sponsor. As outlined in Section 5, Entrants who do not pass the required credit check or fail to provide a valid Tax ID as part of the rental agreement process will be disqualified and an alternate winner will be selected.

## **12. GENERAL TERMS**

Ziegler Inc. reserves the right to modify or cancel the Sweepstakes at any time due to unforeseen circumstances. In the event of a dispute, the Sweepstakes will be governed by the laws of the state of Minnesota.
