

Official Rules of the 2026 "America 250 Sweepstakes" (the "Sweepstakes")

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING. CHANCES OF WINNING ARE DEPENDENT UPON THE NUMBER OF ENTRIES RECEIVED.

This Sweepstakes is governed by the laws of Minnesota. You are not authorized to participate in the Sweepstakes if you are not a legal resident of Minnesota or Iowa. These Official Rules may not be published or distributed without the Sponsor's written consent.

1. SPONSOR

This Sweepstakes is sponsored by Ziegler Inc. located at 901 West 94th St. Bloomington, MN 55420.

2. ELIGIBILITY

The Sweepstakes is open only to legal residents of Minnesota and Iowa (collectively, the "States"), who are twenty-one (21) years of age or older at the time of entry. Entries are void outside the Ziegler Inc. territory ([see map](#)) and where prohibited, taxed or restricted by law. Prize award is contingent upon meeting Sponsor's qualification criteria, including but not limited to passing a credit check and providing a valid Tax ID. Officers, directors, managers, and employees of Ziegler Inc.(the "Sponsor"), and each of its respective parents, subsidiaries, affiliates and related companies and their respective advertising and promotion agencies, consultants and agents, as well as immediate family members and/or those living in the same household of each such person, and any others engaged in the development, production, execution or distribution of this Sweepstakes, are not eligible to participate. 3. DATES OF SWEEPSTAKES

The Sweepstakes begins at 12:00:01am Central Time ("CT") on July 1, 2026 and ends at 11:59:59 pm CT on October 31, 2026 (the "Sweepstakes Period"). Entries submitted before or after the Sweepstakes period will not be eligible.

4. HOW TO ENTER

- Online Entry: Visit <https://info.zieglercat.com/america-250> and follow the instructions to enter the Sweepstakes.

The form must be completed in its entirety by submitting all answers to the form questions. After completing the form, click the "Submit" button. Upon clicking the "Submit" button, Entrant may be prompted to complete the entry form in its entirety to include first name, last name, street address, city, state, zip, phone number and email address (if available)

and click “Continue”. If prompted, entry form must be completed in order to be eligible to win. Then, complete the check boxes and click “Submit” to receive one (1) entry into the Sweepstakes. The form must be completed within the valid Sweepstakes date and by 11:59:59pm CT on October 31, 2026.

OR

- Store Visit: Visit a participating store location in Minnesota or Iowa and complete an entry form. Entrants may, but are not required to, speak with a Ziegler representative about equipment options or promotions

Limit one entry per person, per household, regardless of the method of entry. Any attempt by an Entrant to obtain more than the stated number of entries by using multiple/different identities, and/or any other methods will void that Entrant’s entry and that Entrant may be disqualified from the Sweepstakes. Entries submitted by anyone other than the Entrant are void. In case of dispute as to the identity of any Entrant, entry will be declared made by the registered name and address on such entry. Any potential prize winner may be requested to provide Sponsor with proof that such person is the prize winner.

5. DRAWING ODDS/WINNER SELECTION

On or about November 2, 2026, potential prize winners will be selected in a random drawing from all eligible entries received during the Sweepstakes Period. By entering the Sweepstakes, Entrants fully and unconditionally agree to be bound by these Official Rules and the decisions of the Sponsor and Sweepstakes Entities, which will be final and binding in all matters relating to the Sweepstakes. The odds of winning depend on the number of eligible entries received.

NOTIFICATION OF WINNER

The winner will be notified by phone or email on or about November 2, 2026. If the winner does not respond within five (5) days of notification, the prize will be forfeited and an alternate winner will be selected.

6. PRIZE

One (1) prize will be awarded, consisting of:

- A free rental of a Cat 250 Skid Steer Loader for nine (9) months, from November 11, 2026, to August 11 2027, or until 500 operating hours have been reached, whichever comes first. The total ARV of the rental is \$37,200.
 - Winner must provide a completed IRS Form W-9 before prize award. Sponsor may issue any required tax reporting for the value of the prize.
 - The rental period is expected to begin on or about November 11, 2026, after winner verification and execution of all required rental documents, on a date determined by Sponsor.

7. CONDITIONS
